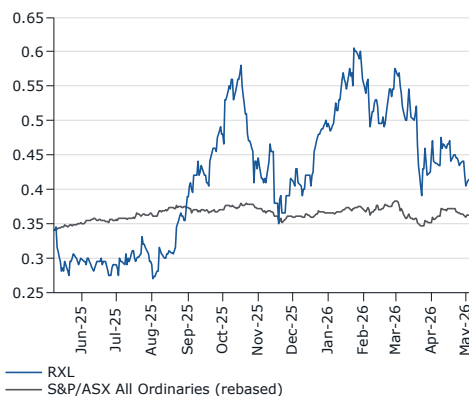

More milestones achieved; dewatering complete

Rox Resources (RXL-ASX) has achieved several major development milestones at the Younami Gold Project in Western Australia as it advances toward production, with dewatering of the Main Pit now complete and underground development accelerating ahead of schedule.

Dewatering: The pit floor is now visible and the historic Main Decline has been exposed, allowing the company to transition from open pit dewatering to underground dewatering through an initial borehole ahead of mining activities. Preparatory works to re-establish access to the pit floor and portals are well progressed, including ramp sheeting, portal access works and face support installation.

Decline and underground development: Development on both the Main and Pollard declines is expected to commence in late May once machinery arrives onsite.

Underground development at United North continues to outperform expectations, with a record 342m of advance achieved during April using only a single jumbo, materially exceeding the rates assumed in the DFS. Ventilation infrastructure has also advanced, with the first ventilation rise successfully fired as part of the primary return airway system. Installation of primary ventilation fans later this month is expected to improve airflow and remove ventilation-related development constraints.

Importantly, early underground mining results are validating the geological model. Face sampling from the first ore lode intersected on the United North 2341mRL level returned a visually controllable mining width of 2.2m grading above 4.99g/t Au, including 0.5m @ 8.32g/t Au along the footwall contact. The second ore lode has also been intersected, with mapping and sampling completed and assay results pending. Ore drive development and ore stockpile building are expected to commence shortly.

Surface activities: Construction and infrastructure activities are also ramping up. Bulk earthworks for the processing plant have commenced following receipt of the Mine Development and Closure Proposal approval, with Interquip expected to mobilise in late May. Accommodation village expansion is progressing, with an additional 300 rooms delivered alongside a new dry mess facility. Borefield drilling has commenced to support future operational water requirements.

Upcoming works: Key project contracts continue to be awarded, including appointment of Pacific Energy for a hybrid power station incorporating thermal, solar and battery capacity. RXL has also executed its Albion Process agreement with Glencore Technology and secured underground drilling services.

RXL remains on track toward production in mid-2027, with near-term catalysts including commencement of Main and Pollard decline development, continued United North ore development, further contract awards and the start of processing plant construction.

Model updates: We have updated our model for the MarQ'26 report, where RXL spent A\$30m of development to end the quarter with A\$200m in cash and access to **A\$350m in debt facilities**. We expect development expenditure to ramp up this quarter now that **FID has been approved**.

Valuation and recommendation: We maintain our risked price target of \$1.30 and our SPEC BUY rating. We have modelled a potential development scenario based on the November 2025 DFS, using weighting for 1.0x forward curve, consensus and spot commodity prices, and have applied a conservative 10% discount rate to our NPV. RXL is currently trading on a P/NAV of 0.33x.

Figure 1: Youanmi Main pit dewatered (looking North) – now at limit of pit pumping



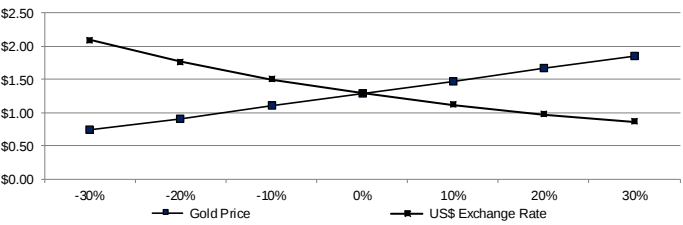

As an exploration/pre-production company with no material income, RXL is reliant on equity and debt markets to fund development of its assets and progress its regional exploration pipeline. Accessing these markets may result in further dilution to shareholders.

Exploration risks

Exploration is subject to a number of risks and can require a high rate of capital expenditure. Risks can also be associated with conversion of Inferred Resources and lack of accuracy in the interpretation of geochemical, geophysical, drilling and other data. It is not known whether exploration will delineate further Mineral Resources, nor that the company will be able to convert the current mineral resource into minable reserves.

Operating risks

If and when in production, the company will be subject to risks such as plant/equipment breakdowns, metallurgical (meeting design recoveries within a complex flowsheet), materials handling and other technical issues. An increase in operating costs could reduce the profitability and free cash generation from the operating assets considerably and negatively impact valuation. Further, the actual characteristics of an ore deposit may differ significantly from initial interpretations which can also materially impact forecast production from original expectations.

Commodity price and currency fluctuations

As with any mining company, RXL is directly exposed to commodity price and currency fluctuations. 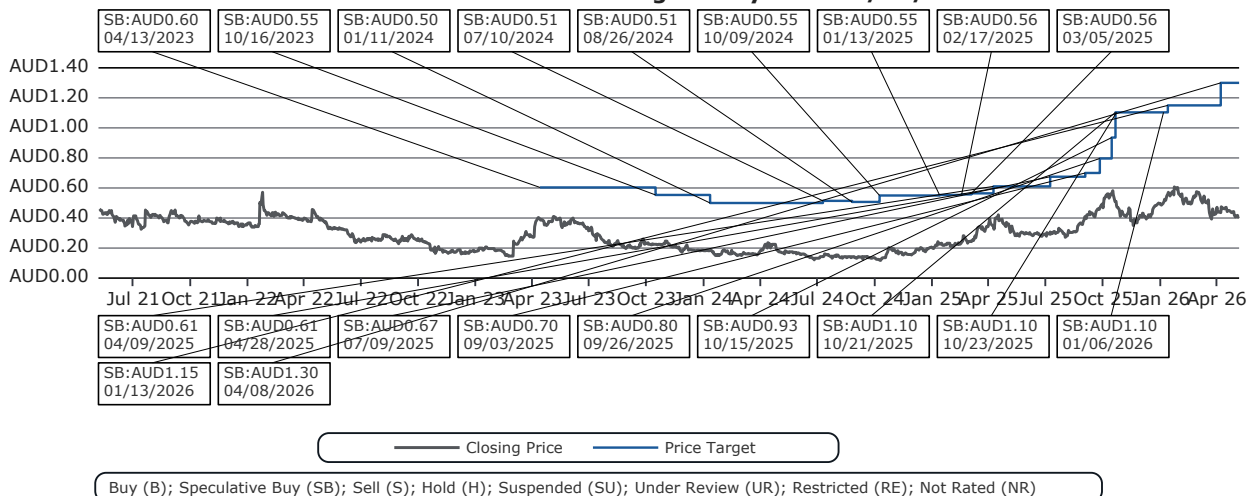
